



The Wine Industry Boosts the Massachusetts Economy by \$6.18 Billion in 2025

The production, distribution, sales, and consumption of wine in Massachusetts benefits many sectors state's economy and generates close to \$6.18 billion in total economic activity. This ultimate value-added product preserves agricultural land, provides American jobs, attracts tourists, generates taxes, and enhances the quality of life.

Total Output: The wine industry generates close to \$6.18 billion in total economic activity in the State of Massachusetts, dramatically illustrating that wine is the ultimate value-added beverage. The broader economic impact flows throughout the state, generating business for firms seemingly unrelated to the wine industry. Real people, with real jobs, working in industries as varied as farming, banking, accounting, manufacturing, packaging, transportation, printing, and advertising depend on the wine industry for their livelihoods.

State Reach: The Massachusetts wine industry includes a total of 63 wine producers¹ as well as 141 acres of vineyards.²

Job Creation: The Massachusetts wine industry directly employs as many as 18,095 people, and generates an additional 6,308 jobs in supplier and ancillary industries which supply goods and services to the industry, and whose sales depend on the wine industry's economic activity. Ultimately, 33,021 jobs are created and supported by the wine industry.

Wage Generation: The Massachusetts wine industry provides good jobs, paying an average of \$65,000 in annual wages and benefits. The total wages generated by direct, indirect, and induced economic activity driven by the wine industry are \$2.15 billion.

Tourist Activity: The Massachusetts wine industry is a major magnet for tourists and tourism-driven expenses. Massachusetts' "wine country" regions generates 423,600 tourist visits and \$80.89 million in annual tourism expenditures, benefiting local economies and tax bases.

Tax Revenues: The Massachusetts wine industry generates sizeable tax revenues on the local, state, and national levels. In 2025, the industry will pay nearly \$394.19 million in state and local taxes, and \$530.86 million in federal taxes for a total of \$925.05 million. In addition, the industry generates approximately \$27.42 million federal consumption taxes and \$92.86 million in state consumption taxes which include excise and sales taxes.

¹ Throughout this study, the winery count refers to the number of winery facilities. A single winery may have multiple facilities throughout the state or country. Each of these facilities is included in the winery count.

² Vineyard acres refer to farmland being used to grow winegrapes statewide.
